Resolution 288, adopted at the 67<sup>th</sup> National Convention and Resolution NC 2-94, adopted at the 23<sup>rd</sup> National Convention of the Sons of the American Legion, calls for designating a POW/MIA "Empty Chair" at all official meetings of The Sons of the American Legion as a physical symbol of the thousands of American POW/MIAs still unaccounted for from all the wars and conflicts involving the United States of America. This is a reminder for all of us to spare no effort to secure the release of any American prisoners

from captivity, the repatriation of the remains of those who died bravely in defense of liberty, and a full accounting of those missing.

- The SAL will host a dinner on January 24, 2026. John Baker will cook, but needs assistance with ordering & serving, meal plating and dishwashing.
- John Baker will not run for Commander for the 2026-2027 year. An officer sign-up list will be placed on the bulletin board on January 1, 2026. The SAL election is planned for May 11, 2026, from 1:00 to 6:00 PM, with ballots counted between 6:00 and 7:00 PM and the new Commander's appointments approved at the 7:00 PM membership meeting. The date for the installation of officers will be after the Legion Convention in June 2026.

### **Unfinished Business:**

• Last month the question arose as to why Squadron 90 only has one Sunday for a 50/50 raffle. John Baker reported that the raffle dates were changed when the Legion requested contributions from SAL, ALA, and ALR to help fund the NFL package. The Legion, SAL and ALA contributed, but the ALR did not. To help pay back the programs, each program was given a Sunday to generate 50/50 funds. Commander Baker has no idea why the ALR was given a Sunday as they did not contribute to the NFL package, but he will try to get and answer before the next meeting.

#### **New Business:**

- The Florida ABT is inspecting all establishments with an 11C liquor license which includes Post 90. Post 90 is adhering to the Florida law which requires all family members (Legion, SAL and Auxiliary) of Post 90 to present their membership card to the bartender before ordering an alcoholic beverage. The bartenders have been instructed to ask for a membership card from everyone. If you do not have your card, you will be treated as a guest and must be signed in by a card-carrying member. Guests cannot purchase an alcoholic beverage which must be purchased by the member.
- If you have not renewed your membership by December 31, 2025, you will not be able to enter the Post except by ringing the buzzer. You will be asked to renew your membership. The American Legion grants a 30-day extension to January 31, 2026, before your membership will expire. If your membership expires you must rejoin, and your continuous years will begin a "1".
- The Post will be closed all day on Monday, November 17 to have a new canteen floor installed. From November 18 to 21, the Post will open at Noon.
- The Legion is instituting an "Honorary Legion Family Member of the Year Award". Each Legion program (Legion, SAL, Auxiliary and Riders) will submit one name to the Legion Commander for consideration of the award. SAL Commander Baker has received two names for the SAL candidate, and if you would like to consider a SAL member, please contact the Commander Baker. The submission for the award will be by an application with a narrative as to why the candidate is given consideration.
- Sean Wing requested suspension of the meeting and that Commander Baker leave the meeting & room and Second Vice Commander Horner preside. Commander Baker complied A motion was made by Sean Wing to make Commander Baker a Life Member of Squadron 90. The motion was seconded by Elon Hertzfeld, Discussion none, Vote: Yeas unanimous, Nays none. The motion passed.

Commander Baker returned to the meeting and presided.
